Message from the President

This year we have moved forward with helping 106 women and 215 children at WINGS, HND and Community Outreach who have experienced family violence. This is a life changing experience for all of the families.

The Board members and Executive Director, Pat Garrett, have successfully completed our 3 year Strategic Plan. It was a large undertaking and required a significant amount of work. At the core of this strategic plan is a vision for WINGS that is focused on delivering new, creative and collaborative ways to maximize long term outcomes for the women and families we serve. As we pursue this strategy, everything we do will be designed to support the most critical of outcomes – a permanent transition to a life free of domestic violence. WINGS is grateful for all of the hard work you have put in, and is thankful for all you will continue to do for WINGS. To all of our members, thank you for your generosity and dedication to WINGS. The slower economy has been affecting all non-profits in Alberta and we appreciate the continued support. Our vision is to move forward with the help and support of many including our exceptional staff, collaborative sector partners, expert academics, generous funders and donors, and with the inspiring families we serve.

Welcome to WINGS of Providence 33rd Annual General Meeting.

The issue of domestic violence is as complex as it is heart wrenching. Our holistic approach to support women and children creates the best possible chance for families to permanently flee a life defined by domestic violence.

This Year at WINGS, our commitment to women and children leaving domestic violence to provide the most effective and trauma informed services remains the top priority. Maintaining and operating WINGS -2nd Stage Shelter which offers 20 fully furnished self –contained apartments and the Home Next Door which offers affordable/social housing in 29 fully furnished apartments provides the core of our programming. The WINGS child care and Rocky Forest Daycare located in the Home Next Door also provide a safe, creative, and fun environment for children as well as remove barriers for their mothers to move forward with their lives. The wonderful new youth room provides a warm, safe and fun space for school aged children and teens to have fun, have groups that cover life skills, healthy relationships, family violence and bullying. The families living in the community who drop in for support and the teens who attend group or participate in teen outings. It certainly takes a dedicated group of concerned citizens to keep WINGS growing stronger.

As we move forward we are committed to our values. These values guide our decision making, our interactions with each other, our donors our supporters and friends. They set the tone for how we show up, how we work and how we respond to adversity. We live by the following values:

Safety-Nothing else matters if we are not safe.

Nominations Committee Report 2019

The WINGS of Providence Society Board of Directors is comprised of up to 15 members in accordance with the WINGS bylaws. After serving a 3 year term, Linda Churchill, Katie Clackson, Jonathan Kitteringham, and Cynthia Zutter have agreed to stand for re-election for a second 3 year term.

After taking her mandatory 1 year absence following 6 consecutive years of service, Dr. Moira F. Juliebo Walker will stand for election for a 3 year term. Moira has been instrumental in assisting WINGS' staff with the opening of the Rocky Forest Daycare, developing polices, as well as fund development. Hannah Barrington and Mika Friesen will each stand for election for a 3-year term. We are excited to have Moira, Mika and Hannah join the Board.

After 12 years of dedicated service, Ellie Merrick resigned from the Board of Directors in May 2019, however, she will remain close friends with WINGS and continue in a volunteer capacity. Ellie has been active in many areas and on multiple committees including the Executive in which she was Vice-President, Personnel, Special Events, and Governance & HR for which she was Chair.

In November of 2018, after 5 years of service, Leigh Newton resigned from the Board. Leigh contributed in many areas including the Executive Committee in which she was Treasurer, as well as the special events committee. Leigh will be greatly missed and Board members wish her the best of luck. In December of 2018, Tami Wetmore was appointed to the Treasurer position.

In April 2019, Nicholas Leong resigned from the Secretary position. Nicholas will remain on the Board of Directors and actively involved in fundraising and on the Community Engagement Committee. In March 2019, Sarah Doyle resigned; the Board wishes her all the best in her future endeavours.

The WINGS' Board of Directors is a strong group of dedicated community based volunteers who govern WINGS. This year there are a total of 9 Board positions to be filled. Hannah Barrington

Hannah is a Registered Nurse, currently working at a busy pediatric clinic that specializes in medically fragile children with multiple diagnoses. She is the past president of the Junior League of Edmonton (JLE), a women's development charity that has partnered with WINGS on a number of projects. JLE dedicates countless volunteer hours to women's leadership training, as well as their impact area of girls' self-esteem and mental health. In 2017, Hannah was recognized as one of Avenue Magazine's Top 40 under 40 for her volunteer work in the community. She was one of the organizers of the Ladies on the Green Charity Golf Classic, from 2014 to 2018; which is a third-party fundraiser, powered by a small committee of community-minded women in Edmonton that has raised over 300K for the Zebra Child Protection Centre. Hannah sits on the Lois Hole Hospital Women's Society Steering Committee, as well as their Community Engagement and Corporate Relations Committee. Hannah is raising 4 feminist children, (three of whom are daughters) with her husband of 19 years, David Jones.

Hannah is passionate about combatting the epidemic that is intimate partner and family violence, and is very proud to have her name put forward as a candidate for the WINGS Board of Directors.

Linda Churchill

Linda began her career at WINGS when it opened in 1987. She will say this is the best career she could have chosen. With a background in accounting and social work Linda began as the Office Manager, and took on the role of Manager of Resources and Development going into the first capital campaign in 2003. Linda was instrumental in the success of this campaign and a pivotal force behind the Home Next Door development, and the successful building completion. Linda always said that WINGS was never just her job; it was her passion. To observe and be part of such important and effective work was always a motive for Linda to give more, push harder, be better, and do her part to eradicate family violence. Then to see all this effort relate to positive changes for the women and children – how can you NOT do this work.

After 28 years of service to WINGS, Linda Churchill announced her retirement in December 2014. WINGS is incredibly grateful to Linda for her hard work and dedication for so many years, as well as for her genuine desire to help women and children affected by family violence in the community. While Linda embraced retirement she whole heartedly decided to join WINGS Special Events Committee and 30th Anniversary Committee, and now will let her name stand for election to the Board of Directors for a second term. Linda's knowledge of WINGS programs and services as well as her 28 years of working hand in hand with the world's best volunteers, staff, and generous donors will make Linda an invaluable addition to WINGS Board. Moira F Juliebo Walker

Moira F. Juliebo Walker, M.Sc.Ph.D., Thouron Fellow, University of Pennsylvania 1967-68, is a graduate of Jordanhill College (Scotland), Froebel College (London), the University of Pennsylvania, and the University of Alberta.

She has taught at all elementary school levels and at various universities in Great Britain and North America.

Presently, she is Professor Emeritus at the University of Alberta where she taught courses in diagnostic reading, early literacy development, and integration of language arts, drama, and language research. She is also the former Director of The Reading and Language Centre.

Her research interests included writing (grades 1-6) intervention programs for young 'at risk' language learners; reading and cognition; teacher education; and autistic children.

She was a sought-after speaker around the world, and has engaged in consulting in the United Kingdom, Continental Europe, the Far East, the Middle East, Canada and the United States.

In her academic life she has been on the Scientific Advisory Board of the International Center for the Enhancement of Learning Potential, Jerusalem, Israel and has worked extensively in Hungary advising on the teaching of English. She holds the Rutherford Award for Excellence in Undergraduate Teaching from the University of Alberta.

Moira was constantly engaged in professional development workshops. Numerous academic publications reflect her teaching and research interests.

On the creative side, with Lita Ericson, she authored "The Phonological Awareness Handbook for Kindergarten and Primary Teachers" published by the International Reading Association. She is also the author of the Read-More series of twenty-four books and a Teacher-Parent guide for early readers and older children with reading difficulties.

As content architect, she developed OWL, an on-line and CD product to teach language arts to children in grades three to six in the United Kingdom and United States. The product consisted of twenty-four narratives carrying interactive language activities and was supported by a massive teacher and parent site. An article on OWL was given The Telisphere Award in 1999 by The Journal of Educational Media.

Throughout her life she has held numerous voluntary positions in the community. At present she is a counselor, clinical hypnotist, a Standardized Patient with Health Sciences University of Alberta, Grant McEwan University and NAIT, a Board Member of the Alberta Lung Association and has co-authored a book on prostate cancer with author Norman Sacuta. Moira is also an artist and published poet.

Cynthia Zutter

Cynthia is an anthropology professor at MacEwan University. For the past two decades, she has been working at MacEwan where her time is spent both mentoring and guiding students to understand their local communities and make choices that are respectful for all. She uses both the classroom and extracurriculum events to educate students about those communities that are less fortunate than themselves. For example, she hosted the "Wardrobe for Women" event March/2019, whereby faculty, administrators and students donated and purchased clothing with the proceeds going to organizations that help women return to the workforce.

Cynthia comes from a family of seven who were born and raised here in Edmonton. She and her four sisters have been participating with the WINGS organization for over ten years and have wonderful memories from the Mother's Day Tea celebrations, Ladies Night Out and other events. She is excited to be part of the WINGS Board of Directors for a second term, and will support the strategic direction of the organization as it moves towards new and innovative ways to support for women in need.


